**SPECIAL ORDER OF FOREST SUPERVISOR  
UINTA-WASATCH-CACHE NATIONAL FOREST  
PLEASANT GROVE RANGER DISTRICT**

**EMERGENCY FIRE ORDER**

**PROHIBITIONS:**

Pursuant to Title 36 CFR 261.50 (a) and (b) **the following acts are prohibited** on the areas and roads as described in this order, all lands within the Pleasant Grove Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect until further notice.

1. **Being in or upon the area** as described below. [ 36 CFR 261.53(e)]
2. **Being on the road** as described below. [36 CFR 261.54(e)]

**EXEMPTIONS:**

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

**AREA DESCRIBED:**

All Uinta-Wasatch-Cache National Forest System Lands North of American Fork Canyon Road (SR 92) to the Utah/Salt Lake County line, and north and east along Pole Line Pass Road (Forest Service Road #085) to the Forest Boundary, as shown on attached map.

American Fork Canyon Road (State Road 92) to the junction with Cascade Scenic Drive (Forest Service Road #114), as shown on attached map.

**PURPOSE:**

Purpose of the closure is to provide for public health and safety during fire suppression efforts of the Quail Fire.

**IMPLEMENTATION:**

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. Attached map shows the area affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual, or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b)(6)], [Title 18 USC 3581(b)(7)].
4. 5. This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order in the areas (and/or roads or trails) covered by this Order.
