Fire Restriction Order

Due to current and forecasted weather conditions coupled with the extremely dry condition and heavy loading of vegetation throughout the State of Utah, the State Forester has determined that measures must be taken to prevent costly and damaging forest and rangeland fires. Therefore, pursuant to Utah State Law, Section 65A-8-212 Utah Code 1994. The following acts are prohibited on the areas, roads and trails described below until rescinded by the Utah State Forester:

1. Setting, building, maintaining, attending or using open fires of any kind, except campfires built within the facilities provided for them in improved campgrounds, picnic areas or permanently improved places of habitation.
2. Smoking, except within an enclosed vehicle or building, a developed recreation site or while stopped in an area at least three feet in diameter that is barren or cleared to mineral soil.
3. Discharging, or using any kind of fireworks, tracer ammunition or other pyrotechnic devices.
4. Cutting, welding, or grinding metal in areas of dry vegetation.

Area Description: All unincorporated private and state lands within the State of Utah except Salt Lake County. Restrictions in Salt Lake County will apply to those unincorporated areas previously designated by Unified Fire Authority as closed to 'fireworks only'. For open burning and fireworks restrictions regarding the unincorporated areas of Salt Lake County please refer to the 'Open Burning and Fireworks Restrictions' map which can be viewed at www.UnifiedFire.org or http://www.unifiedfire.org/pdf/Fireworks_RestrictedAreas.pdf.

In addition to the prohibited acts listed above, the following acts are also prohibited in the area described below.

5. The use of any steel jacketed or steel core ammunition of any caliber
6. Use of exploding targets that are detonated when struck by a projectile such as a bullet from a firearm

Area Description: All unincorporated private and state lands within Box Elder, Tooele, Utah, Weber Counties and the unincorporated areas in Salt Lake County previously designated by Unified Fire Authority as closed to 'fireworks only'. For open

burning and fireworks restrictions regarding the unincorporated areas of Salt Lake County please refer to the 'Open Burning and Fireworks Restrictions' map which can be viewed at www.UnifiedFire.org" or http://www.unifiedfire.org/pdf/Fireworks_RestrictedAreas.pdf.


This order does not affect incorporated towns and cities.

Effective 12:01 A.M., 23rd day of June, 2012.

The following persons are exempted from the above prohibitions:

1. Persons with a permit specifically authorizing the prohibited act at a specific location.
2. Any State or Federal Fire Officer or firefighting forces in the performance of an official duty.

Violation of the above prohibited acts is punishable as a class B misdemeanor.
